

For this reason, to contribute in stemming the spread of global pandemic and for post-pandemic use, it is crucial to provide protective fabrics, with antiviral, antibacterial and antimicrobial properties.

Meryl Medical has developed Meryl® Skinlife with HeiQ Viroblock Permanent, a technology which infuses silver-ions active ingredients into the matrix of the yarn. This advanced technology ensures that no germs or microbes can grow in the fabric. The silver-ion active ingredient carry a positive charge and attracts the negatively charged microbes and rapidly oxidate these organisms, blocking their ability to spread.

Our Hydrogen Technologies also allows an even longer durability of the garments, thanks to the molecular composition of the yarn. This results in continuous microfilaments, with natural stretch that do not release microfibrils. Therefore, this innovation is helping the fabric and clothing industry move forward sustainable and full circular economy.

Meryl Skinlife Force is active against the main groups of bacteria Gram + (S. Aureus) and Gram - (K. Pneumonia). Thanks to the presence of antimicrobial agents in the polymer matrix, there is no tissue migration to the skin, avoiding the induction of allergy.

The active ingredient of Meryl Skinlife Force has been registered and certified by the United States Environmental Protection Agency (US EPA 85249-1) and by the US FDA (Food and Drug Administration).

Advanced care and protection thanks to the combination of gold with hyaluronic acid bonded nanoparticles together with silver ions. The active principle is added to the molecular structure of the yarn during the spinning process to create the permanent effect.

Gold with hyaluronic acid particles act directly on skin cells, stimulating their own hyaluronic acid production achieving moisturizing, firming and antioxidant properties. Silver ion technology inhibits completely the proliferation of bacterias and viruses in the fabric, assuring completely odorless and protective garments.



# RECYCLING & CIRCULARITY

WE CLOSED THE LOOP!

1. We collect our yarns and garments at the end of their useful life
2. They go through a physical process in which they are converted back into base polymer. Phases:
  1. Melting of the initial product
  2. Filtering of impurities
  3. Cutting of the base polymer back to pellets
3. This polymer is used to manufacture yarn with the same properties as virgin yarn, which in turn is available for new masks.
4. The 100% of the original garment is recycled





## CERTIFICATIONS OF EXCELLENCE

The high-tech Meryl® Skinlife Force fabric is certified by Oeko-Tex 100 STANDARD, ensuring that the product is free of toxic substances. The silver active principle of Meryl Skinlife Force has been registered by the United States Environmental Protection Agency (US EPA 85249-1) and by the US FDA (Food and Drug Administration).


